Event Guidelines & Vendor Agreement

- Vendor booths must be set up by **8:00 a.m.** and staffed and ready to operate by **10:00 a.m.**
 - Event hours are **10:00 a.m. – 7:00 p.m.** daily. Booths are expected to remain open during event hours.
 - Tear-down may begin at **6:00 p.m.** and must be completed by **7:30 p.m.**
 - Vendors must provide their own **tent and chairs**.
 - Vendors are responsible for cleaning their booth area.
 - BEHE is not responsible for lost or stolen items or any equipment not owned by BEHE.
 - Only one organization/vendor is permitted per booth space. Vendors must conduct business within their assigned booth only.
 - Non-registered vendors may not distribute merchandise or promotional materials.
 - Vendors are responsible for obtaining all required permits and licenses.
 - The event committee reserves the right to prohibit the sale or distribution of any materials deemed illegal or offensive. Any conduct not approved by the committee may result in removal from the event without refund.
